Attendance was taken by roll call and quorum was confirmed.

**CDC Meeting Minutes** – Mr. Caimano made a motion to approve the April 2023 CDC meeting minutes and Mr. Ms. King seconded. All voted in favor by roll call vote.

**CDC Financial Review** – Mr. Robinson reviewed the CDC financial activity thus far for 2023. Mr. Campbell made a motion to approve the CDC financials and Ms. Sullivan seconded with all voting in favor by roll call vote.

**Resolution to approve Adirondack Housing Association bond modifications** – Mr. Joe Scott stated that Adirondack Housing Association formally requested that the IDA approve modifications to their bond and underlying financing documents necessary to implement the change from the LIBOR variable rate index to the SOFR variable rate index.

Mr. Scott noted that LIBOR is being replaced by SOFR worldwide and this will still be federally tax exempt with no other changes to be made to this bond agreement, so a public hearing is not required.

Mr. Scott stated that no other WWCDC bonds will be affected by the variable rate index modification as this bond is the only project that has variable rates versus fixed rates.

Mr. Robinson made a motion to approve the resolution authorizing modifications to the Adirondack Housing Association LLC bond project and Mr. Gonzales seconded with all others in favor by roll call vote.

**Adjournment:** There being no other business, Mr. O'Brien made a motion to adjourn the May Board Meeting for the WWCDC adjourned at 4:32 pm.

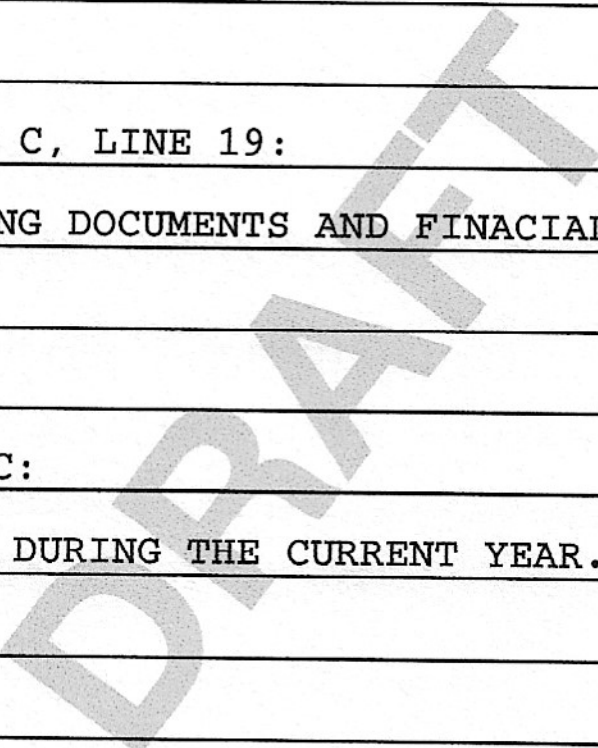
